I. OPEN MEETING

- N. Veazie opened meeting at 6:02 pm
- Members Present- N. Veazie, M. Kelley, R. Gray, and D. Gray

II. APPROVAL OF MINUTES

- July 7, 2025 Meeting Minutes- M. Kelley made a motion to accept the minutes as written. R. Gray 2nd the motion. Discussion- None. Vote- 4-0.
- July 21, 2025 Meeting Minutes- R. Gray made a motion to accept the minutes as written. M. Kelley 2nd the motion. Discussion- None. Vote- 4-0.
- July 28, 2025 Special Meeting Minutes- M. Kelley made a motion to accept as written. D. Gray 2nd the motion. Vote- 3-0. R. Gray abstained as he wasn't present at meeting.

- **d. Community Resilience Partnership-** J. Williams read the Community Resilience Partnership Resolution. R. Gray made a motion to accept and adopt the resolution as written. M. Kelley 2nd the motion. N. Veazie signed the resolution on behalf of the board. Discussion- K. Gray stated went over the quote from Anderson Windows. The weatherization assessment is being performed August 8th and the 11th. Vote- 4-0
- **e. Digital Sign-** Dig Safe has been done. They are hoping to install on August 15th.
- **f. Legal Representation-** K. Gray reached out to Farrell Rosenblatt and Russell they are supposed to reach back out to K. Gray.
- **g. Parking lot Paving-** There was a lengthy discussion about the parking lot. R. Gray stated he didn't remember the board ever discussing starting the parking lot in a meeting. N. 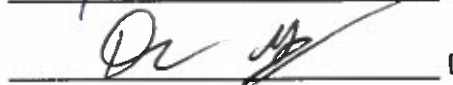
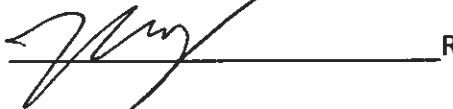
