- **Selectmen-** N/A

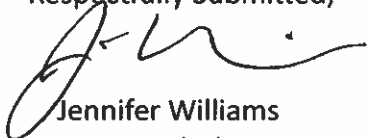
VIII. EXECUTIVE SESSION 1 M.R.S.A. § 405 (6)(C)

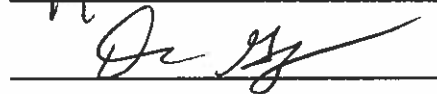
IX. ADJOURNMENT-

Vote- 5-0.

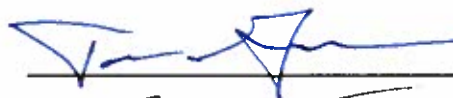
