 - 2nd year- \$19.25 yrd
 - 3rd year- \$19.25 yrd
 - **Contract Price**
 - 1st year- \$184,800, per mile \$6,600
 - 2nd year- \$188,440, per mile \$6730
 - 3rd year- \$191, 240, per mile \$6,830
 - Any additional year will be \$194,040, per mile \$6,930
- **b. Roadside mowing-** The board said to open and post the bid for roadside mowing.
- **c. St. Joseph Agreement-** R. Gray made a motion to table until we have more information from fire or ems. They also would like a copy of said agreement.

- **f. Bangor Humane Society Stray contract-** N. Veazie signed the contract.

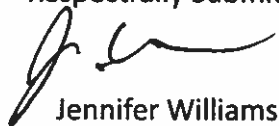
VII. OPEN SESSION
